Commodity: Bookstore Management Services

Please Note: This amendment is issued to amend the RFP as detailed below

- Q1) Would NMIMT accept an electronic response in lieu of a mailed paper response?
- At this time, we kindly ask that all responses be submitted in hard copy, as we are not currently set up to receive electronic submissions.
- Q2) Please provide a further detailed category breakdown of textbook sales information from the past few years, including new, used, rental, digital, and inclusive access.
- A2) Further details are unavailable.
- Q3) Please provide a further detailed category breakdown of retail sales information from the past years, including, but not limited to, trade books, clothing, computers/technology, convenience, gifts, etc.
- A3) Based on five-year averages, sales are as follows: supplies \$40,000; soft goods \$170,000; and sundries \$70,000.
- Q4) Are there any sales reflected in the historical sales numbers that were a result of a one-time grant or other funding that will not occur in the future?
- A4) No, the historical sales figures do not include any sales that resulted from one-time grants or other non-recurring funding sources.

- Q5) What percentage of the courses utilize free OER content?
- A5) Currently, 2% (two percent) of courses utilize free OER (Open Educational Resources) content.
- Q6) Does NMIMT have any direct agreements in place with publishers or other third-party course material providers?
- A6) No, New Mexico Tech does not currently have any direct agreements in place with publishers or third-party course material providers.
- Q7) What is the current process for students to utilize their financial aid funds through the bookstore?
- A7) Students receive a refund check the Friday before classes begin, which can be used to cover bookstore purchases and other educational expenses.
- Q8) Which term would the new bookstore partner begin serving the campus population?
- A8) The new bookstore partner will begin serving the campus population in the Fall of 2025.
- Q9) Does NMIMT utilize a Campus Card that can be used to purchase materials in the bookstore? If so, what company is used to manage it?
- A9) No, NMIMT does not currently utilize a Campus Card for purchasing materials in the bookstore.
- Q10) Is NMIMT open to self-operating a spirit store (apparel, merchandise, sundry items, etc.) with an online bookstore vendor providing all student-purchased materials shipped directly to the campus bookstore for student pickup?
- A10) Yes, we are open to the idea.
- Q11) Would NMIMT consider partnering with two separate vendors with two separate agreements to provide textbook operations and retail services if it deemed this more beneficial than a single vendor?
- A11) Yes, we would consider it as an option.
- Q12) Would NMIMT be open to a full-service online solution where the apparel, merchandise, and course materials are all sold through an interactive online platform with no permanent physical presence on campus?
- A12) No, NMIMT is not currently open to a full-service online solution.
- Q13) Would NMIMT be open to paying a management fee to the vendor to help subsidize the oncampus retail store operation costs?
- A13) No, NMIMT is not currently open to paying a management fee

- Q14) Does NMIMT own the current bookstore fixtures?
- A14) Yes, NMIMT owns the current bookstore fixtures.
- Q15) What is NMIMT's Student Information System?
- A15) NMIMT's Student Information System is Banner.
- Q16) What is NMIMT's Learning Management System?
- A16) NMIMT's Learning Management System is Canvas.
- Q17) Does NMIMT have any Inclusive Access course material adoptions? If so, how many courses have inclusive access adoptions?
- A17) No, New Mexico Tech (NMIMT) does not currently have any Inclusive Access course material adoptions.
- Q18) Would NMIMT be interested in implementing an Equitable Access solution, an in-tuition solution where all course materials are automatically delivered to all students with the costs included as part of the cost of attendance?
- A18) Yes, we can explore Equitable Access but could not implement until the academic year beginning August 2026.
