

May need to work independently or collaboratively in a team environment. Perform other job related duties as assigned. NMT has a remote/hybrid work policy and this position may qualify.

Experience in writing reports with at least one high-level report-writing language package. Experience in web development languages (e.g. Groovy on Grails, Python, Ajax, Java/JavaScript). Demonstrated ability to interact with end-users to discern problems and arrive at solutions. Demonstrated ability to interface different software products together. Experience with Ellucian/Banner ERP systems. Experience with Evisions/Argos reporting tool. Knowledge of accounting principles, Linux O/S, higher education administrative systems.
